## Interview & Fee Deposit Dates:October 21 – 23, 2024Interview Venue:Department of Law, Block BInstructions:

Candidates must bring the following documents to the interview:

- 1. Original educational documents.
- 2. LAT result/report.
- 3. Original bank deposit slip for the application fee.
- 4. Copies of CNICs of the applicant and parents/guardians.
- 5. Copy of domicile of the applicant.
- 6. Character certificate from the head of the institution last attended.
- 7. Equivalence certificate from IBCC (if applicable).
- 8. Candidates applying for reserved/quota seats must provide relevant documents/certificates confirming their eligibility for the applied seat.
- 9. Attested copy of Advocate's License for advocate's children quota

All Photocopies must be Attested.

## Note.

a. Admission is contingent upon verification of required documents to meet eligibility criteria.

b. Candidates failing to appear for the admission interview will lose their seat, which will be offered to the next candidate on merit. Similarly, selected candidates must complete all admission requirements, including fee submission, within the notified period; otherwise, their seat will be offered to the next candidate on the waiting list.

- c. If any student is found to have submitted fake or altered documents at any stage, their admission will be canceled without notice.
  - d. Selected candidates must submit an affidavit, signed by both the student and their parent/guardian, agreeing to adhere to the University's rules and regulations.
